



# CASE STUDY

## EFFECTIVE SAFEGUARDING AUDITS AND REVIEWS

To conduct thorough safeguarding audits and reviews across a group of schools, ensuring compliance with KCSIE and statutory requirements to implement best practices to protect staff and students.

### **1. Initial Assessment and Planning:**
